

# UNDERSTANDING YOUR SHARED MINISTRY 2016 CALCULATION & CHURCH ASSESSMENT

## Local Church Expenses Include:

### #1

- Pastor's Compensation (Line 48-49)
- Pastor's Housing Expenses Paid (i.e. utilities housing allowance) (Line 50)
- Pastor's Reimbursable Expenses (Line 51)
- Deacon's & Diaconal Ministers salary (Line 53 -54)
- All other Church Staff Salaries (Line 55a)
- Church portion of Payroll Taxes (Line 55b)
- Amounts paid to other staff that is not on the church payroll. (i.e substitutes, guest pastors, and other self-employed staff) (Line 55c)
- Church portion of Staff Health Premiums paid to Other Companies NOT the Conference (excluding the Pastor's) (Line 55d)
- Church program expenses (Line 56)
- Utility Expenses paid (Line 57a)
- Church property maintenance and repair expenses (Line 57b)
- Church office supplies expense (Line 57c)
- Property and Liability Insurance premiums paid to Other Companies NOT the Conference (Line 57d)
- Amount paid to use other church or organization facilities (Line 57e)
- Other Operating Expenses (Line 57f)

**2016 Shared Ministry Formula:**

Local Church Expenses **divided by** All GNJ Church Expenses **multiplied by** the Total 2016 Shared Ministries Plan (Conference Budget) **equals** Your Local Church Shared Ministry Assessment for 2016

OR

$$\frac{\text{Local Church Expense}}{\text{All GNJ Church Expenses}} \times \text{2016 Conference Budget} = \text{Your Church's Shared Ministry obligation for 2016}$$

**2015 Shared Ministry Formula Applied to Your Church:**

$$\frac{\$59,040}{71,291,774} \times \$11,998,609 = \$9,937$$

**Local Church expenses include:**

- Lines 48-57 of Table II of the 2014 Local Church Year End Statistical Report
- Billed amounts for 2014 CPP, CRSP, Health Insurance, Property Insurance and Workers Comp
- Line 44 (Non-Methodist Benevolences) only if the Local Church did not pay 100% of its prior year Shared Ministry Obligation (First Mile Giving)

**Local Church expenses do NOT include:**

- Line 58 - Total paid for principle and interest on indebtedness, loans, and mortgages
- Line 59 - Total amount paid on capital expenditures for buildings, improvements and major capital equipment purchases
- Line 52 - Any moving expenses reported on this line
