St. John United Methodist Church (Fordville) Fordville, New Jersey

Methodism came to the Bridgeton area of NJ through itinerant preachers. In 1799 Rev. Michael Swing visited the area. To some he is the "father" of Methodism in this region. In the intervening years, the Old Stone Church in Fairton was a start. Then, the locally known Swing's Meeting House. Under Rev. Reuben Cuff, a meetinghouse in Gouldtown. Various other buildings served as school, meeting house, or church for local Methodist societies.

Rev. Peter Schureman dedicated the Lummis School, moved from Gouldtown, renaming it Ebenezer. However in 1841 the church split as a group, including founding members Jacob Pierce, Adrian Pierce, Freeman Pierce, Hosea Pierce and the families and followers who sought another path, an ethnic path to maintain their ethnic, native roots. It took a while but with God's help this group built their first building, a one-room log cabin, which served both as schoolhouse and meetinghouse; named The Piercetown School and Meetinghouse.

In 1861 the church began plans to build a church which became St. John Methodist Episcopal Church, incorporated in 1863 as the Methodist Episcopal Church of Fordville. It was finally dedicated in 1865.

Much of the history is lost, except in some oral form. One thing certain, St. John was strongly connected to a remnant of the Lenni Lenape Community (also known as Tribe) in the Delaware Bay region. The building served as meeting house and school when no other was available to the Tribe. Improvements and additions were made in the ensuing years. Then in 2001 a small fire in the parish hall—a quickly contained fire—revealed major and extensive structural deterioration. The building was condemned and torn down. In May 2013 a new all purpose building was dedicated.

Native American heritage permeates the weekly service of worship. From prayers, to songs, to the youth drumming and dancing during a worship, the heritage is present. On the fifth Sunday worship is described as "total immersion." St. John is a welcoming and diverse church to compliment this Lenni Lenape heritage.

Over the years many trials and tribulations were met with the power of faith. A lawsuit emanating from the split, economic hardship, isolation as a native American congregation, death of a pastor (Rev. Richard Wilson while preaching), and in 1938 categorized as African-American and transferred to the Central Jurisdiction, Delaware Conference. Yet faith saw them through to this day.

St. John enabled the Tribe to remain strong in the Christian faith as well as their Native-American heritage. Church members are on the tribal council. Recent church contributions to the Annual Conference and beyond included:

- A 2015 Basic Skills/Bible Camp curriculum that focused on a bridge to Christian teaching and cultural ways. This camp attracted attention from Christian educators.
- Members are part of the District, Conference Committee on Native American Ministries (CONAM). Some are part of the Northeast Jurisdiction CONAM.
- Members contributed to the recent Service of Repentance.
- A member of the Tribe has been asked to lead an opening prayer at Annual Conference.
- Some church members act as missionaries to reservation communities across the country.
- The Tribe and the St. John assisted in hosting duties for the Native American International Caucus in Vineland NJ October, 24-30, 2016. Members have attended previous meetings.
- Though on hiatus, the church is working with GNJC Archives and History on an oral history project.

With the strength of the Great Spirit God, St. John United Methodist Church (Fordville) remains the only Native American rooted church in the conference. With a history dating to 1841, and well before that to the earliest itinerant preachers, St. John is strong in Christ as they minister to their community, the True Path, the Way, that all God's Children are intended to walk.

Recommendation

St. John United Methodist Church (Fordville), Cumberland County, NJ, Historic Site

Whereas St. John United Methodist Church (Fordville), inFordville, New Jersey is the home to many members of the Nanticoke Lenni Lenape Nation in Cumberland County New Jersey

Whereas many church members and Elders of the Tribe can trace Methodist roots back to the ministry of Reverend Michael Swain, who first itinerated to area in 1799.

Whereas predecessor families of the St, John United Methodist Church (Fordville) split off from neighboring churches to form a Methodist Episcopal Church to maintain their tribal roots and traditions; and this congregation was chartered in 1841.

Whereas the church building has been a place of meeting for tribal affairs when none were available or allowed a place of ministry to help the spiritual and physical needs of those in need.

Whereas disciples from St. John United Methodist Church (Fordville) currently serve on the Tribal Council of the Nanticoke Lenni Lenape Nation; one for over forty years.

Whereas St. John United Methodist Church (Church) once self-identified as a "hidden" church, because its heritage was not welcomed by Caucasian Methodists who forced it into the segregated Delaware Conference and since has become a leader in Native-American ministries to The United Methodist Church of Greater New Jersey reaching beyond to Northeast Jurisdiction.

Whereas St. John United Methodist Church (Fordville) assisted the Annual Conference to plan a Service of Repentance, as directed by the 2012 General Conference.

Whereas St. John United Methodist Church (Fordville) is a diverse congregation with strong Native American heritage that welcomes all who come to worship in many styles; including fifth Sunday heritage services, which engage youth as drummers and dancers.

Be It Resolved that The United Methodist Church of Greater New Jersey recognize St. John United Methodist Church (Fordville), in Fordville, New Jersey as an Annual Conference Historic Site for its unique ministry among the Nanticoke Lenni Lenape Nation.


Rationale: St. John United Methodist Church (Fordville) is a historic Native American congregation with strong roots and ties within the African American and Anglo communities, as well as members of the Nanticoke Lenni Lenape Nation. Since the coming of Methodism around 1799, member families, who split from other churches in order to maintain their Native American heritage, have continued to worship God as Methodist Christians. In recent years this "hidden" church has become active in the Greater New Jersey Conference and beyond to share their heritage and ministry. The disciples of the Church are celebrating 175 years of history and ministry. It is appropriate to recognize their milestone for a unique and faithful church.
